REGISTRATION OF GHANAIANS IN THE KINGDOM OF SAUDI ARABIA, HASHIMITE KINGDOM OF JORDAN, KINGDOM OF BAHRAIN AND SULTANATE OF OMAN FOR A PROPOSED EVACUATION EXERCISE TO GHANA

The Embassy of the Republic of Ghana in Riyadh and the General Consulate in Jeddah, Saudi Arabia presents its compliments to all members of the Ghanaian Community in Saudi Arabia, Kingdom of Bahrain, Hashimite Kingdom of Jordan, Sultanate of Oman and wishes to inform that, the Embassy has on the directives of the Government of Ghana commenced compiling a list of Ghanaians desirous of being evacuated to Ghana due to the outbreak of global health emergency at the highest magnitude caused by the novel Corona virus (COVID-19) pandemic.

- 2. Additionally, the purpose of this exercise is **ONLY** for collection of information to enable the Government of Ghana plan and take decision in relation to safe facilitation and evacuation of stranded Ghanaians in the abovementioned countries in COVID-19 situation.
- 3. Owing to the above, the Embassy further wishes to request all Ghanaians in these countries interested to be evacuated to urgently forward information required below through the official email addresses and the contact phone numbers of the Embassy in Riyadh and Jeddah General Consulate respectively.
- 4. However, Ghanaians in the **Kingdom of Bahrain, Hashimite Kingdom of Jordan and Sultanate of Oman** are kindly requested to send their information to the Embassy in Riyadh, Saudi Arabia.

- 1. Full name (as in Passport)
- 2. Contact details (Telephone number)
- 3. Passport Details (If any)
- 4. Date of Issue
- 5. Date of Expiry
- 6. Exit and Re-entry or Final Exit Visa 9 (If any)
- 7. Current location (Country and City)
- 4. Information received will be compiled and forwarded to the Government of Ghana for consideration. Once arrangements are concluded, interested registered persons will be accordingly notified.
- 5. The Embassy in Riyadh and the Consulate General in Jeddah are making intensive efforts, closely monitoring the situation and taking all the required measures to ensure the welfare of Ghanaian citizens. In this regard, Ghanaians compatriots resident in these countries are strongly advised to continue with the strict observance of the standard health protocols and preemptive measures issued by the concerned agencies of the hosts authorities on the Corona virus pandemic and contact nearby hosts health facilities and officials in case of COVID-19-related symptoms tested positive immediately in ensuring quick medical assistance.
- 6. In conclusion, Embassy will take all the necessary measures to work in coordination and cooperation with major companies, volunteers, social workers, prominent and local Ghanaian Community Associations across these countries for a successful exercise.
